Iceland

Dr. Lilja Sigrún Jónsdóttir writes that the Medical Women's Association of Iceland is waiting for summer here in Iceland now, still getting some sleet and snow. But the MWAI in Iceland has been busy with a gender medicine session recently at a local CME congress and a historical display of the work of our first female physician educated and working in Iceland.

The Netherlands

Congress Region Northern-Europe 19 -21 May, 2011 in Breukelen

The central theme of this congress was *Women on the Move*, which expresses the continuing change of the situation of women all over the world.

Professor Margriet Sitskoorn delivered the opening lecture: *Greed and the social brain*. She emphasized that the brain is always trying to get a balance between pain and pleasure. Our behaviour is directed to reach that balance.

In the session on *Women's Health, Reproductive Health*, the speakers elucidated the problems of providing safe abortion where it is illegal, the situation on maternal and perinatal mortality in the Netherlands and the current status of HPV-vaccination.

The Friday morning session was devoted to *Gender Specific Medicine*. The key note lecture concerning Gender Medicine in Daily Practice was given by Professor Toine Lagro-Jansen. It was followed by 4 workshops on gynaecocardiology, domestic violence, preconception advice and gender differences in depression, respectively. Each participant could attend to two workshops. The session on Migration and Health was opened by Professor Halleh Ghorashi. Being a refugee herself, she accentuated that refugees are not only victims, but are very eager to start a new life. Health care for illegal people and the integration of refugee doctors in the Dutch health care system were subjects of the other lectures.

Saturday morning professor Emile Aarts paid attention to the technical possibilities in the coming years, summarized as *ambient intelligence*. Very important to make a success of this, is to place people in the centre of the developments and not the apparatus.

Based on a cross-sectional survey of Dutch medical students, residents and doctors, two

medical students could conclude that gender is the most important factor to explain how macho male students and doctors are. They found that gender differences are most obvious among students and residents. In a PhD study it was found that women doctors are not less ambitious than male doctors. The last contribution of the lung specialists Pauline Dekker and Wanda de Kanter on motivational interviewing showed that it is not enough to tell your patients to stop smoking. In a play let they showed how to motivate the patients to think about their smoking behaviour and how tot try to stop it. The social program consisted of a get together and a walk to the village of Breukelen on Thursday evening and a canal cruise with dinner in Amsterdam on Friday evening.

CELEBRATION OF 15 YEARS WOMEN STUDIES IN MEDICINE IN NIJMEGEN

26th, 27th and 30th May the 15th Anniversary of the Chair of Women Studies in Medicine in Nijmegen, the Netherlands was celebrated with international invitational conferences.

The chair was founded in 1996 by the Dutch Association of Women Doctors (VNVA). Professor Toine Lagro-Janssen made this chair and the field of gender specific medicine very successful and in 2003 it was taken over by the University of Nijmegen.

Two conferences concerned the introduction of gender into the medical curricula and the education of residents. It is clear that this differs between countries and that a lot of work has to be done. The last day was devoted to Intimate Partner Violence and to strategies to deal with this important problem in daily practice.

The spring meeting held in Northern Wales on May 6, 2011, was a great success. It was entitled, *Women and Mind Altering States, or Menywod a Cyflwr Newid Meddwl*, with reference to Alice through the Looking Glass. Speakers included Professor Ian Gilmore, President of the Royal College of Physicians, Chris Weaver, Substance Misuse Midwifery Lead BCU, Ruth Marks, Commissioner for Older People Wales, and Dr Nicola Steedman, Consultant HIV Physician, Countess of Chester. With an aging population being a challenge everywhere, Wales is leading the UK in having a Commissioner for Older People.

The winners of the Katherine Branson Student Essay Competition presented their winning entries. Catherine Carver spoke on "Is prostitution acceptable as a means of supporting one's studies" and Joanna Mathison was the winner for "When is the right time for medics to have a baby?"

The MWF Autumn meeting will be held November 11, 2011, in London. The theme is **Women's Health**. Sir Michael Marmot, who chaired the WHO Social Determinants of Health Project, is a confirmed speaker and will attend the Conference dinner at the House of Lords.

Dr. Edith Schratzberger-Vécsei writes that the annual scientific conference of the "Austrian Medical Women" held in Vienna on November 19th 2010 was a great success. The motto of the meeting was "Feminisation in Medicine"; it provoked big discussions and was met with approval as it is a raising problem amongst female medical doctors in a world that is still ruled by their male colleagues.

Together with the department of "Gender Medicine" in Innsbruck we will arrange a meeting at University Hospital Innsbruck on September 30, 2011 on a gender topic.

We are proud to inform that we could gain Konrad Paul Lissmann (very popular Austrian philosophic) and Michael Musalek (well known Austrian psychiatrist) for our scientific meeting that will take place on November 12th 2011 in Vienna. This year's topic will be: "Lust und Sucht" ("Desire and Addiction"). We are looking forward to welcome many colleagues and interested people of any other profession to discuss and enjoy the meeting with us. (further information: www.aerztinnenbund.at)

Germany

Dr. Diekhaus writes that at the 114th German Medical Assembly (Deutscher Ärztetag) I had the privilege to represent MWIA. The meeting took place in Kiel /Schleswig- Holstein from 31 May- 3 June 2011. The German Medical Assembly is the annual meeting of the German Medical Association, the "parliament of the medical profession" in Germany. It has been held every year since 1873 with a few exceptions.

The State Chambers of Physicians send a total of 250 delegates to the German Medical Assembly each of them representing about 145 doctors. The delegates discuss and adopt cross-state professional regulations on, for example, the model professional code (Musterberufsordnung) and the model regulations on specialty training (Musterweiterbildungsordnung). They also formulate the standpoints of the medical profession on current health-related and socio-political debates.

This year the main topics of discussion were pre-implantation diagnostics, organ donation and palliative care.

It was also the year of election: the President and two Vice- Presidents of the German Medical Association are elected by the Assembly for a term of four years. The new President is Dr. Frank Ulrich Montgomery; one of the two Vice-Presidents is a very capable medical woman, Dr. Martina Wenker, who was at our congress in Muenster last year and is enthusiastic about MWIA.

There were also many foreign guests, among others the President of the Swedish Medical Association, Marie Wedin , the President of the Bosnian Medical Association (Prof. Lazarevic) who was very interested in MWIA, the Minister of Health of the Republic of Kosovo (Ferid Agani) , the first chair of the Russian Medical Chamber (his name only in Russian letters which I cannot read), the VP of the Czech Medical Chamber (MUDr). Mrozek) , the SG of the Russian Medical Society (Mikhaylov). I had talks about MWIA and the possibility of supporting a national women's association with all of them. Furthermore I met Wonchat Subhachaturas as current President of the World Medical Association (2010- 2011) and President Elect of the Medical Association of Thailand. He stressed that he would very much like to participate in our Western Pacific Regional Meeting in Bangkok next year.

United States

AMWA's 96th Annual Meeting was held on March 31-April 3, 2011 in Arlington, VA, in conjunction with the 19th Annual Congress on Women's Health. The meeting presented wonderful opportunities to network, mentor and collaborate on women's health issues and the advancement of women in medicine. If you were unable to attend this year's meeting, here are some of the highlights!

The meeting opened with AMWA's Annual Advocacy Day, held in partnership with Physicians for Reproductive Choice and Health. The main issue focused on Title X funding, the federal grant program for family planning and reproductive health services for low-income and uninsured patients. In, Attendees participated in a two hour training session where they learned how to advocate on Title X and shared stories from patients prior to meeting with legislators on the Hill.

Meeting attendees also enjoyed high quality CME sessions provided by the Congress, including topics such as reproductive health, cardiovascular health in women, controversies in mammography, obesity management, memory disorders, cervical cancer screening, and osteoporosis management – and a special session with Surgeon General Dr. Regina Benjamin. AMWA distributed 5000 patient education brochures on Vitamin D, which were developed in partnership with the Bone and Joint Decade and Healthy Women, a non-profit organization serving as the nation's leading independent health information source for women. (Take the Healthy Women Survey found later in this issue of *NewsFlash* to help us develop future patient education materials.)

AMWA also held its second annual Networking Alliance meeting, bringing together over twenty professional organizations dedicated to advancing women in medicine. This year's meeting focused on gender equity and featured presentations by AMWA's Gender Equity Co-chair, Dr. Linda Brodsky and renowned speaker, Sara Laschever, author of *Women Don't Ask: Negotiation and the Gender Divide*.

AMWA's signature event is the Awards Gala. This year, AMWA's Presidential Award was presented to two exceptional women who have been integral in bringing women's health issues to the forefront: Regina Benjamin, MD, MBA, Surgeon General, Vice Admiral USPHS and Margaret A. Hamburg, MD, Commissioner of Food and Drugs. Additional women honoured at the Gala included: Valerie Montgomery Rice, MD-Elizabeth Blackwell Award; Katherine Wisner, MD, MS- Women in Science Award; Saralyn Mark, MD-Lila A. Wallis Award; Beatrice Sachs, MD (posthumously)- Bertha Van Hoosen Award; Adrienne Clark- Anne C. Carter Leadership Award; Sarah Hagy-Camille Mermod Award. Dr. Mary Guinan was welcomed as the new President of

AMWA and Dr. Eliza Chin was thanked for her service to the organization throughout her presidency and tenure on the Board. AMWA also welcomed new members of the Board including: Dr. Gayatri Devi, Incoming President, Dr. Ana Maria Lopez, Secretary, Dr.'s Eleni Tousimis, Suzanne Harrison, and Kelli Cohen Fein as Directors and the new National Student President, Adrienne Clark.

AMWA continues to provide members with opportunities to network, develop, collaborate, learn, and gain recognition for their contributions to medicine. For 96 years, AMWA members have lead the charge to promote gender equity in the field of medicine and to promote the unique needs of women's health care.

MWAN is actively involved in the activities of Nigeria Medical Association As part of our Advocacy Programs, a State Branch had her representatives attend Kuramo Conference 2010 an International Coloquium on Law and Development..

The new website (http://mwan.org.ng) became functional in January 2011.

MWAN is passionate about achieving and maintaining health for all women and children with emphasis on Women's Rights to Health Information (WORTHI).

MWAN is involved in promoting the health of women and children in Nigeria by organizing outreach to women in the communities including market places, prisons, and children in the motherless babies' homes; health awareness campaign and public health education and screening for diabetes, hypertension, cervical and breast cancer of women in the various local government areas as well as sensitization workshops on reproductive health. Members of the National Youth Service Corps and undergraduates are not left out of these campaigns and screening. Training of Trainers on Visual Inspection of the Cervix using Acetic Acid has been carried out both at national and state levels to help in the early detection of cervical cancer.

State branches are working on different aspects of this safe motherhood and reproductive health issues by setting up Family Planning projects, community outreach campaigns, lectures and workshops for women groups as well as post abortion care services. Free blood donation centres have been set up in some states. We have carried out community outreach to include men who are decision makers in family planning issues. The International Women's Day was celebrated with free breast cancer screening for women and health talks in various states. Awareness campaign billboards on Breast cancer have been put up in various states with many of the chapters working on different aspects of cancer research and prevention.

They are to be commended for their book, entitled *Happy Healthy Women—Not Just Survivors*.

AFMW Report on Happy Healthy Women Not Just Survivors Project for AFMW By Dr Raie Goodwach, President VMWS/ Associate Professor Jan Coles, Vice President AFMW

The Australian Federation of Medical Women (AFMW) is building on its "Happy Healthy Women Not Just Survivors" project aimed at improving the health and wellbeing of the one in three women in Australia who are survivors of sexual trauma.

In 2010 the first stage of the project delivered three key elements: a comprehensive literature review – which highlighted how little research there was detailing an integrated, holistic understanding of the psychological, physiological and socioeconomic impacts of sexual violence; an audit of medical school and post-graduate curricula – which showed that there was no national curriculum teaching medical students or doctors about the health consequences of sexual violence; and a National Summit at which key stakeholders including doctors, lawyers, police and community groups identified five key areas which need to be addressed to promote health equity (see www.afmw.org.au)

Doctors need to understand the way survivors can be affected over their lifetime to treat them holistically and not inadvertently retraumatise them as part of ordinary medical practice. - 8. <u>MUSKOKA INITIATIVE</u> Canada's Prime Minister Stephen Harper held a press release from Deauville, announcing support for new health initiatives to help save the lives of mothers and children in Africa and Asia as part of the Canadian-led Muskoka Initiative launched at the G-8 Summit in June 2010.

Targeting the leading causes of mortality in mothers and children in countries such as Sudan, Tanzania, Nigeria, Mali and Afghanistan, the new initiatives will support comprehensive and integrated approaches to provide the necessary health services for mothers and children.

New health initiatives include:

Establishing 24-hour emergency obstetrical and neonatal care hospitals in Southern Sudan;

Helping to immunize 24 million children and pregnant women against preventable diseases, helping to prevent mother-to-child transmission of HIV, and providing

antenatal and delivery care to four million women in Tanzania;

Supporting additional antenatal care visits, increasing the availability of skilled birth

attendants, and increasing access to contraceptives, post-delivery

checkups, bed nets, as well as the number of infants fed with breast milk in

Nigeria;

Strengthening the referral and evacuation system for pregnant women, reducing the rate of malnutrition in children, and pregnant and nursing women, as well as

providing women with better access to the health services they need in

Mali;

Training community health practitioners and increasing the access and use of health services for women and children in underserved areas of Afghanistan. day win-

Helping to reduce child hunger and undernutrition in children and pregnant women in select

developing countries, including Africa and Asia, by targeting the

1,000-day window from pregnancy to age two.
